Also in recognition of their contribution to Brown & Carlson, we are pleased to announce James 'Fritz'

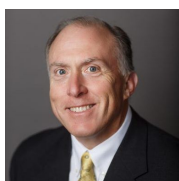
Hauschild and Chris Yoshimura-Rank have become **Shareholders** of Brown & Carlson.

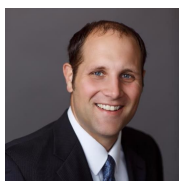

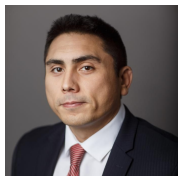
